Submission is through the HQR Secure Portal-Outpatient Chart Abstracted. Previous CART users may enter abstractions into the HQR abstraction tool. Outpatient Quality Reporting Specifications version 18.0b

May 15, 2026

- Influenza vaccination coverage among health care personnel (HCP/IMM-3) Q4 2025- Q1 2026 (10/1/2025-3/30/2026) aggregate data is due **May 15, 2026**. Submission is through NHSN.
- Reporting Patient Left Without Being Seen (OP-22) for CY 2025 encounters (1/1/25-12/31/25) is due **May 15, 2026**. Submission is through the HQR Secure Portal-Outpatient. Outpatient Quality Reporting Specifications version 18.0c.

July 8, 2026

- Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) Q1 2026 encounters (1/1/26-3/30/26) is due **July 8, 2026**. Submission is through the HQR Secure Portal-Vendor. Quality Assurance Guidelines V.19.0

July 31, 2026

- Emergency Department Transfer Communication (EDTC) Q2 2026 encounters (4/1/26-6/30/26) is due **July 31, 2026**. Connect with your State Flex Program for submission process details.
